Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Vehicle Loading	Vehicle accidents, Falling objects	3H	<ul style="list-style-type: none"> - Conduct a pre-work risk assessment to identify potential hazards specific to the location and type of carcass. - Ensure all workers involved in loading are trained in manual handling techniques and safe vehicle loading procedures. - Use appropriate personal protective equipment (PPE), such as gloves, steel-capped boots, high visibility clothing, and eye protection, to reduce the risk of injury. - Implement a spotter system where one person guides the loading process to ensure safety from ground level. - Use mechanical lifting devices, such as cranes or hydraulic tailgate lifters, to minimise manual handling and potential strain injuries. - Secure all loads using appropriate restraints, such as tie-down straps, to prevent shifting during transit and falling objects. - Maintain clear communication among all team members throughout the loading process to coordinate movements and ensure safe practices. 	2M

Carcass Collection	Exposure to biological hazards, Injuries from aggressive animals	4A	<ul style="list-style-type: none"> - Ensure all personnel are trained in handling animal carcasses safely and understand the associated biological hazards. - Use personal protective equipment (PPE) such as gloves, masks, and eye protection to minimise exposure to biological hazards. - Implement effective hygiene practices, including washing hands thoroughly after handling carcasses and before eating or drinking. - Utilise appropriate tools and equipment designed for the safe collection of carcasses to limit direct contact. - Establish clear protocols for the immediate reporting and management of any injuries sustained during carcass collection. - Maintain distance from aggressive animals by using barriers or enclosures where possible. - Carry animal deterrents or noise-making devices to safely distract or deter aggressive animals. - Ensure adequate first aid facilities and trained first aid personnel are readily available at the collection site. - Regularly inspect and maintain equipment to ensure it is in good working order and does not pose additional hazards. - Clearly mark areas where carcasses are being collected to keep unauthorised persons away from potential hazards. - Coordinate with wildlife control professionals when dealing with dangerous animals that may still be present near the carcass. - Schedule collection activities at times when aggressive animals are least active, based on species behaviour patterns. - Use mechanical lifting aids or team lifting techniques to prevent strains or sprains from handling large or heavy carcasses. 	3H

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
