Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.</p> <p>Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.</p> <p>The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

The diagram is an inverted pyramid with five levels, from top to bottom:

- Elimination:** Remove the hazard.
- Substitution:** Replace the hazard.
- Isolation:** Isolate People from the hazard.
- Engineering:** Isolate the hazard.
- Administrative:** Change the work.
- PPE:** Personal Protective Equipment.

Preparation	Slips, trips and falls, Animal bites or scratches	2M	<ul style="list-style-type: none"> - Ensure all workers have completed appropriate training in animal handling, including understanding animal behaviour and techniques to minimise the risk of injury. - Inspect and maintain all necessary personal protective equipment (PPE) such as gloves, safety boots, and long-sleeved shirts to protect against potential bites or scratches. - Keep the work area clean and well-lit, free from clutter and debris that may cause slips, trips, and falls. - Establish designated pathways for walking and moving around the work environment, clearly marked and free from obstacles. - Employ gentle, calm, and non-threatening handling techniques to reduce stress for the animals, which can decrease aggressive reactions. - Schedule routine breaks for handlers to rest and recover, reducing fatigue-related errors and accidents. - Regularly conduct hazard assessments and update Safe Work Method Statements (SWMS) to ensure processes remain current and efficient in addressing potential risks. - Post clear warning signs in areas where animals are kept to notify other workers about the specific risks associated with animal handling and enforce exclusion zones where necessary. - Implement a buddy system for workers when handling larger or unpredictable animals, ensuring support is available in case of an emergency. - Provide easy access to first aid kits in the work area, along with an established procedure for reporting and treating any injuries sustained during animal handling. - Establish clear communication channels between the team members and supervisors, reinforcing safe work procedures and encouraging open discussion regarding safety concerns. - Assess each specific task with the animal and identify any hazards specific to that undertaking; devise suitable control measures tailored to address those particular risks, incorporating them into the SWMS. 	1L

			<ul style="list-style-type: none"> - Calm and stress-free environment: Keep noise and distractions to a minimum to support a calm atmosphere and reduce animal stress, which could contribute to incidents. - Gradual Introduction: Introduce animals to restraint gradually and in a controlled manner, allowing them to become familiar with the equipment to reduce stress and panic. - Animal behaviour observation: Always be aware of animal behaviour and signs of distress, which might indicate an increased likelihood of escape or injuries. - Appropriate protective clothing: Provide and enforce proper personal protective equipment (PPE) while handling animals, such as gloves, closed-toe shoes and long-sleeved shirts, to minimise injury risk from handling tools and animal interactions. - Monitoring workload: Rotate team members involved in animal restraint or limit consecutive hours of work to prevent fatigue and reduce concentration levels that may contribute to errors and accidents. - Emergency planning: Develop an emergency plan that outlines procedures in case of animal escapes or other related incidents. This should include designated roles for staff, communication protocols, and contingency plans for capturing escaped animals. - Continuous improvement: Regularly review and update practices to identify areas that might require additional precautions or improvements in processes, aiming to prevent potential mishaps related to animal restraint efforts.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
