Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Stock Introduction	Stress from handling, possible injuries due to fish weight	3H	<ul style="list-style-type: none"> <li>- Provide comprehensive training for all staff on safe handling procedures and recognising signs of stress in fish.</li> <li>- Use appropriate personal protective equipment such as gloves and non-slip footwear to minimise stress from handling.</li> <li>- Implement a buddy system during stock introduction to ensure proper support handling heavy fish.</li> <li>- Ensure that netting and transfer tools like fish slings are appropriately sized and maintained to reduce the risk of injury.</li> <li>- Limit handling time by preparing transport containers and holding tanks in advance to streamline the transfer process.</li> <li>- Schedule periodic rest periods during stock introduction for workers to prevent fatigue-related mishaps.</li> <li>- Establish clear communication protocols among staff during fish handling to coordinate actions effectively.</li> <li>- Monitor environmental conditions like water temperature, oxygen levels, and salinity to optimise conditions for fish wellbeing.</li> <li>- Arrange for veterinary checks before introduction where applicable to ascertain fish health and potentially reduce stress.</li> <li>- Ensure sufficient space within holding areas to avoid overcrowding, allowing fish ample room for acclimatisation.</li> <li>- Utilise automatic or semi-automatic lifting devices to assist with moving heavier fish, reducing strain on handlers.</li> <li>- Apply calm, deliberate movements when transferring fish to minimise sudden stressors.</li> <li>- Introduce fish into their new environment gradually to allow time for both fish and water parameters to stabilise.</li> <li>- Regularly inspect and maintain aquaculture infrastructure such as tanks and raceways to prevent any unexpected failures or hazards during stock introduction.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
