Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Incorrect footwear, Unfamiliarity with stairs layout	2M	<ul style="list-style-type: none"> - Conduct a site-specific induction to familiarise workers with the stairs layout, highlighting any unique features or potential hazards. - Ensure all workers wear appropriate footwear that is non-slip and suitable for stair use, such as closed-toe shoes with good grip. - Install clear signage at the top and bottom of the stairs to alert workers to exercise caution or alert them to any specific stair-related hazards. - Perform a risk assessment focusing on stair use to identify additional site-specific risks not initially considered. - Maintain adequate lighting in stairwells to ensure all steps are clearly visible and can be navigated safely. - Implement a housekeeping policy that ensures stairs are kept free from obstructions, debris, and spills which might pose a slipping risk. - Provide handrails on both sides of the stairwell where possible and ensure they meet code standards for height and stability. - Regularly inspect the stairs for any damage, uneven surfaces, or worn materials that need repair or maintenance. - Establish a maximum stair occupancy load to prevent overcrowding and potential accidents during high traffic periods. - Instruct workers to keep one hand free while using stairs to allow for easy access to the handrail. - Equip workers with appropriate PPE if necessary based on specific job tasks or identified risks like high noise levels which might distract from safe stair navigation. - Develop and communicate emergency procedures for stair evacuation in case of fire or other emergencies requiring quick and orderly descent. - Schedule regular safety meetings to reinforce safe stair usage practices and address any new concerns that arise from daily operations. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
