Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Arrival at Store	Traffic accidents, pedestrian incidents	2M	<ul style="list-style-type: none"> - Conduct a pre-arrival risk assessment to identify potential traffic and pedestrian risks specific to each store location. - Ensure team members are trained in safe driving techniques, including defensive driving and awareness of high-traffic periods. - Use designated parking areas and avoid parking on busy streets or near loading zones whenever possible. - Utilize crossing points, pedestrian walkways, and footpaths to minimize exposure to vehicle traffic while walking from the parking area to the store entrance. - Equip team members with high-visibility clothing or vests to enhance visibility to drivers and other pedestrians upon arrival. - Establish communication protocols for reporting any traffic hazards or incidents noticed during arrival to increase awareness and address them promptly. - Schedule arrival and departure times to coincide with low-traffic periods to reduce exposure to vehicular movements at peak hours. - Adhere to local traffic laws and store-specific guidelines regarding speed limits within the parking area and surrounding roads. - Encourage carpooling or use of public transport where feasible to reduce the number of vehicles arriving simultaneously and to lessen parking congestion. - Provide access to up-to-date information about any ongoing roadworks, temporary traffic rearrangements, or changes in parking procedures near the store location. 	1L

Entering the Shop	Physical assault from bystanders, Slip over wet floor	2M	<ul style="list-style-type: none"> - Ensure staff is trained in conflict resolution and de-escalation techniques to handle potential confrontations with bystanders. - Install visible security cameras that act as a deterrent against aggressive behaviour from bystanders. - Position security personnel or loss prevention officers at entry points for immediate assistance in case of an incident. - Use clear signage to guide customers safely, minimising the risk of physical altercations due to overcrowding. - Conduct regular hazard assessments to identify slip areas within the shop and address them promptly. - Place "Wet Floor" signs to warn individuals of slip hazards, particularly after cleaning activities or when inclement weather increases moisture. - Apply non-slip mats near entrances and frequently wet areas to reduce the likelihood of slips and falls. - Implement a housekeeping schedule to ensure spills are cleaned up immediately and floors are kept dry. - Educate employees on the locations and proper use of emergency response equipment like panic buttons and duress alarms. - Encourage staff to work in pairs during high-risk hours for increased safety against physical assault. - Design entryways with adequate lighting to enhance visibility and deter criminal activities. - Use barriers or stanchions to control foot traffic and prevent collisions or accidental contact between staff and customers. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
