Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Inadequate training, lack of personal protective gear	3H	<ul style="list-style-type: none"> - Conduct comprehensive training sessions for all participants to ensure they understand the rules and potential risks associated with ball games. - Provide participants with a clear understanding of emergency procedures, including how to safely retrieve balls from dangerous areas. - Ensure that all participants are wearing appropriate personal protective gear such as helmets or knee pads, especially for younger players. - Develop a safety briefing that outlines the risks of balls entering roadways or dangerous areas and distribute it to all participants and supervisors. - Implement a buddy system where more experienced players can guide and assist less experienced or younger participants. - Post warning signs around the playing area indicating the hazards of balls entering the roadway or other dangerous areas. - Establish a boundary around the play zone using cones, ropes, or similar markers to delineate safe playing areas from hazardous zones. - Have supervisors or designated safety officers monitor games to ensure adherence to safety protocols and intervene when necessary. - Equip staff with high-visibility vests to signal their authority and ensure they are easily recognisable during play activities. - Arrange periodic safety audits to assess the adequacy of training, equipment, and boundary markers, making adjustments as needed. - Involve local traffic authorities if necessary to discuss possible additional signage or warnings for passing vehicles near playing areas. - Encourage an open culture where participants feel comfortable reporting near-misses or safety concerns, allowing for continual improvement in safety practices. 	2M

Game Commencement	Collision with other vehicles, stray ball entering roadway	4A	<ul style="list-style-type: none"> - All players must attend a safety briefing before the commencement of the game to understand potential hazards and emergency procedures. - Clearly delineate the playing area with cones or flags, ensuring it's adequately distanced from roadways and other dangerous areas. - Assign a designated safety officer to monitor the boundary lines and signal if a stray ball enters hazardous zones. - Implement a buddy system, where players are paired, and each is responsible for keeping an eye out for their partner during play for any potential guidelines breaches. - Position spotters around the perimeter of the field to alert players if they get too close to restricted areas. - Use signage to clearly mark boundaries and warn of approaching roads or dangerous zones adjacent to the playing area. - Introduce a rule that immediately stops play if a ball is approaching a roadway, with a protocol for safe retrieval. - Ensure all players wear high-visibility vests or distinctive clothing to be easily seen by motorists if stray balls need retrieving. - Establish a buffer zone between the edge of the playing area and the roadway, where no active gameplay is permitted. - Regularly inspect playing equipment and fields for any changes or damages that could pose additional risks. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
