Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Falls, Trips, and Slips, Inhalation of Chemicals	2M	<ul style="list-style-type: none"> - Conduct a pre-job briefing to familiarise all workers with the potential hazards and safety measures related to the treatment area. - Clearly mark and secure the work zone with warning signs and barriers to prevent unauthorised access during treatment. - Use personal protective equipment (PPE) such as gloves, goggles, and masks specifically designed for chemical resistance to mitigate inhalation risks. - Ensure that all vents and HVAC systems are turned off or sealed to prevent the spread of chemicals beyond the treatment area. - Maintain adequate ventilation in the room being treated by opening windows where possible to help disperse chemical fumes. - Utilise non-slip matting or shoes with slip-resistant soles to reduce the risk of falls, trips, and slips when working on potentially slippery surfaces. - Keep the work area organised by ensuring cables, tools, and equipment are stored safely and away from walkways to prevent tripping hazards. - Develop a spill response plan and train all workers in its execution to quickly address any accidental chemical spills. - Store chemicals in properly labelled and sealed containers in a designated area to avoid accidental exposure and inhalation. - Schedule regular breaks for workers to minimise fatigue and ensure they remain alert and aware of their surroundings. - Provide appropriate first aid equipment and ensure at least one staff member trained in first aid is present during the treatment process. - Perform a visual inspection of the workplace prior to beginning work to remove any existing tripping hazards like debris or loose flooring. - Implement an emergency evacuation plan specific to chemical exposure incidents and rehearse it regularly with all workers. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
