Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Manual handling injuries, slip and trip hazards	3H	<ul style="list-style-type: none"> - Conduct a manual handling assessment prior to the commencement of work to identify potential risks. - Ensure all workers are trained in proper manual handling techniques and understand the importance of maintaining a neutral spine position. - Use mechanical aids such as trolleys or lifting devices to transport heavy materials where possible to minimise manual handling risk. - Arrange the work area to minimise twisting, reaching and bending by placing frequently used items within easy reach. - Encourage team lifting for awkward or heavy loads to distribute the weight evenly and reduce strain on individual workers. - Ensure that all tools and equipment are in good working condition and placed in designated storage areas when not in use to prevent creating obstacles. - Maintain clean tidy workways free from unnecessary objects to mitigate slip and trip hazards. - Use signage to mark any temporary obstructions or potential hazards on the floor surfaces. - Select appropriate non-slip footwear for the conditions of the worksite to provide additional grip and stability. - Implement a routine housekeeping schedule to regularly check for and rectify spillages or debris on floors. - Ensure adequate lighting in all working areas to improve visibility and awareness of potential hazards. - Consider using anti-fatigue mats to reduce worker fatigue and retune circulation during prolonged standing periods. - Assess weather conditions if outdoors, and adjust schedules and precautions for wet or slippery conditions as required. - Provide ergonomic support resources, such as cushions or adjustable workstations, to enhance comfort and reduce strain during lengthy tasks. 	2M

Site Set-up	Unstable ground, electrical hazards	4A	<ul style="list-style-type: none"> - Conduct a thorough site inspection to identify unstable ground conditions and mark or barricade these areas. - Implement appropriate Personal Protective Equipment (PPE) such as high-visibility vests, helmets, and steel-toe boots for all personnel on site. - Ensure all electrical installations and equipment are tested and tagged by a qualified electrician before commencing work. - Establish exclusion zones around potential electrical hazards and unstable ground areas to restrict access to authorised personnel only. - Provide training to workers on recognising and avoiding unstable ground and electrical hazards specific to the site. - Develop and communicate an emergency response plan that includes procedures for incidents related to unstable ground and electrical shocks. - Regularly review weather forecasts and assess how conditions like rain might exacerbate unstable ground risks; adjust work plans accordingly. - Use temporary stabilisation measures such as reinforcing mats or gravel fill for areas identified with unstable ground until permanent solutions are applied. - Schedule regular tool box talks focusing on hazard recognition and control measures related to both unstable ground and electrical safety. - Maintain clear and open communication lines between team leaders and workers to promptly address any emerging risks related to site conditions. 	3H

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
