Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Slip, trip and fall hazards, Lack of machine guarding	2M	<ul style="list-style-type: none"> - Ensure that the work area is clean and free from any obstacles, debris or spills to minimise slip, trip and fall hazards. - Inspect the floor for any cracks, uneven surfaces or obstacles which could pose a risk to workers' safety. - Clearly mark walkways and safe working areas to help guide worker movement around the bottle capping machine. - Provide adequate lighting in the workspace to ensure workers can easily spot potential hazards. - Hold regular toolbox talks and safety training sessions to educate workers on proper procedures, hazard identification and injury prevention related to the bottle capping machine. - Install appropriate machine guarding to cover moving parts, pinch points and other hazardous areas of the bottle capping machine to prevent worker injuries. - Implement lockout/tagout procedures on the bottle capping machine to ensure that machinery cannot accidentally be restarted during maintenance, cleaning or other tasks that require direct interaction with the machine. - Provide non-slip footwear for all workers, ensuring it is comfortable and properly fits each employee to reduce the risk of slipping on wet or slippery surfaces. - Conduct regular risk assessments to inspect and verify the effectiveness of implemented control measures and identify additional hazards that may arise during the process. - Encourage workers to report any potentially hazardous conditions they observe immediately to management, allowing for quick action to rectify the problem. - Supply workers with the proper personal protective equipment (PPE) - such as gloves, safety shoes, and protective eyewear - relevant to their role when working with or around the bottle capping machine. - Perform routine maintenance and inspection of the bottle capping machine to ensure it's in optimal working condition, reducing the risk of malfunctions that could lead to hazards or accidents. - Establish an emergency response plan for the workspace, outlining the designated meeting point, escape routes, and first aid provision in case of any accidents involving the bottle capping machine or other equipment within the work area. 	1L

			<ul style="list-style-type: none"> - Require employees to report any loose, damaged, or ill-fitting parts of the machinery immediately, in order to prevent malfunctions that may lead to crushing hazards or pinch point injuries. - Ensure clear communication among workers involved in the bottling process to avoid surprises or unintentional actions which might lead to accidents due to crushing hazards and pinch points. - Designate specific areas around the machine where workers are safely able to feed bottles into the equipment to keep them clear from hazardous areas. - Develop and implement a formal lockout/tagout procedure to disable the machine during cleaning, maintenance, or repair activities, preventing accidental restarts that could pose risks to workers. - Display prominent signage and warning labels near the bottle capping machine to remind workers of the potential hazards associated with the equipment and advise them to take necessary precautions when working nearby. - Establish a system for regularly reviewing and updating standard operating procedures (SOPs) to ensure adequate controls are in place to prevent crushing hazards and pinch points from occurring during the bottle feeding process. - Employ ergonomic designs for workstations and tools used throughout the bottle feeding process, providing workers with the ability to complete their tasks without excessive force or strain resulting in exacerbated risk of injury. - Foster an open atmosphere within the workplace that encourages workers to report any concerns or suggestions regarding safety improvements, allowing management to address potential hazards in a proactive manner.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
