Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> - Make sure that a Ground Fault Circuit Interrupter (GFCI) is installed on all electrical outlets near the work area to prevent electric shock. - Keep Brick Dipping Tank setup clear from water sources or any wet surface, which can increase the risk of electric shock. - Provide proper lighting in the equipment setup area, so workers have clear visibility while handling the tank and other tools. - All electrical equipments should be connected to a common earthing point in the workplace, to avoid potential buildup of static electricity. - Maintain a safe, clutter-free environment by removing any unnecessary or unrelated items and materials around the dipping tank area. - Secure any cords, hoses or tubing running through the work area by using cable protectors or cord covers to prevent tripping hazards. - Utilize proper signage to clearly warn of potential hazards, like electricity and trip-risk areas, present in the workplace. - Ensure workers are adequately trained and informed about the dangers associated with their tasks and are aware of how to handle the equipment safely. - Maintain open communication channels, allowing workers to report any hazards observed in their environment promptly. - Implement a standard operating procedure (SOP) that outlines the steps for safely setting up and using the brick dipping tank, as well as for responding to incidents and emergencies. - Regularly review control measures and modify them accordingly if new hazards or risks are identified. It is essential to keep the SWMS up-to-date and relevant to the workforce's evolving needs.

Pre-dipping process	Splashes or spills of chemicals, Inadequate ventilation	2M	<ul style="list-style-type: none"> - Properly train employees in the handling, use and storage of chemicals involved in the brick dipping process. - Provide appropriate personal protective equipment (PPE) such as goggles, gloves, aprons, and safety boots to minimise contact with harmful substances. - Clearly label all chemical containers and tanks with their respective contents and hazard warnings. - Implement a spill response plan in case of accidental spills or splashes, including easily accessible spill containment and clean-up materials. - Provide eye wash stations and emergency showers near the work area for immediate decontamination in case of chemical exposure. - Assess the ventilation system to ensure adequate air exchange is occurring, preventing the buildup of harmful fumes in the workplace. - Train workers on the specific symptoms of overexposure to chemicals used in the dipping process and how to seek prompt medical care if needed. - Establish a buddy system that ensures at least two employees are present during the pre-dipping process to watch out for any potential issues. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
