If an incident or a near miss occurs, all work must sto, quately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Site Inspection	Trip hazards, Falling objects	3Н	 Conduct a thorough site inspection prior to commencing brick and masonry cleaning work, identifying any potential trip hazards, loose materials, or other unstable objects. Implement a system for regular inspection and maintenance of the worksite to ensure that potential hazards are identified and addressed promptly throughout the brick and masonry cleaning process. Ensure proper housekeeping practices are in place by keeping walkways and work areas clear of debris, equipment, hoses, and cords to minimise trip hazards. Mark and communicate any identified trip hazards that cannot be immediately resolved, either through signage or bright coloured tape, to alert workers and prevent potential accidents. SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.
