Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Delay work if necessary until conditions improve. - Implement a communication system, such as two-way radios or mobile devices, for clear and effective communication between machine operators and ground personnel. - Store hazardous materials appropriately (such as fuel or chemicals) in designated areas with secondary containment to prevent spills and leaks. - Ensure team members handling hazardous materials are equipped with proper personal protective equipment (PPE) like gloves, goggles, and face masks. - Develop an emergency response plan covering potential incidents related to unstable ground, machinery accidents, or hazardous material exposure and regularly conduct drills to ensure preparedness. 	2M

Excavation	Cave-ins, Falling equipment/material, Accident with heavy machinery		<ul style="list-style-type: none"> - Conduct a site-specific risk assessment prior to commencement of excavation work to identify potential hazards and implement control measures. - Establish exclusion zones around excavation sites to prevent unauthorized personnel from entering areas where they could be at risk from cave-ins or falling materials. - Use appropriate shoring, bracing, or battering techniques to stabilize the excavation walls and prevent cave-ins. - Regularly inspect excavation sites for signs of instability, such as cracks or water ingress, and take corrective actions immediately. - Develop and implement a communication plan to ensure all workers are aware of evacuation procedures and emergency response plans. - Ensure that all operators of heavy machinery are properly trained and hold the necessary certifications for the equipment they are using. - Install barriers, warning signs, and physical barricades to alert workers and visitors about the danger zones and prevent accidental entry. - Maintain a safe distance between heavy equipment operations and other personnel on site to minimize the risk of accidents or collisions. - Employ spotters to assist equipment operators with maneuvering in tight or complex environments and provide guidance to avoid obstacles and personnel. - Use appropriate personal protective equipment (PPE) such as hard hats, high-visibility vests, and steel-toed boots to protect workers from potential hazards. - Implement a traffic management plan to coordinate the movement of vehicles within the site, minimizing congestion and potential accidents. - Conduct daily toolbox talks and safety briefings to reinforce safety protocols and encourage worker vigilance regarding potential hazards. - Provide adequate lighting for excavations occurring in low-light conditions to ensure clear visibility of the work area and reduce the likelihood of accidents. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
