ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Slips, trips, falls, Unorganised work environment	3H	<ul style="list-style-type: none"> - Conduct a pre-start meeting to discuss the specific hazards related to the work area and tasks, ensuring all workers are aware of risks and control measures. - Ensure the work area is well-lit to enhance visibility and decrease the likelihood of slips, trips, and falls. - Use appropriate signage and barriers to clearly identify hazardous areas and restrict access to authorised personnel only. - Implement a housekeeping schedule to regularly clear debris, tools, and materials from the worksite, maintaining an organised environment. - Ensure workers wear appropriate personal protective equipment (PPE), including non-slip footwear and high-visibility clothing. - Install temporary edge protection or guardrails in areas where there is a risk of falling. - Ensure all cords, hoses, and cables are secured and routed to prevent creating trip hazards. - Designate clear walkways and ensure they remain unobstructed to allow for safe movement around the worksite. - Regularly inspect scaffolding and ladders to ensure they are stable and maintained according to safety standards. - Provide adequate training for all workers on safe manual handling techniques and hazard awareness specific to the construction of bulkheads. - Develop an emergency response plan that includes procedures for handling incidents related to slips, trips, and falls, and ensure all workers are familiar with these procedures. 	2M

Machine Installation	High voltage, Improper handling of machinery	4A	<ul style="list-style-type: none"> - Conduct a pre-start safety briefing to inform all workers of high voltage risks and safe machinery handling procedures. - Ensure all workers are trained and competent in operating machinery, with certifications on hand as necessary. - Implement lockout/tagout (LOTO) procedures to ensure machinery is de-energised and disconnected from power sources before maintenance or installation begins. - Use insulated tools and wear appropriate personal protective equipment (PPE), such as rubber gloves and boots, to minimize the risk of electrical shock. - Maintain a safe distance from live wires and high voltage equipment, using barriers or warning signs to denote hazard zones. - Assign a qualified electrician to oversee the electrical components of machine installation and verify compliance with regulatory standards. - Use lifting and rigging equipment correctly; assess load weights and capacities to prevent improper handling or equipment failure. - Regularly inspect machinery and tools for damage or malfunction prior to usage to ensure they are in safe working condition. - Establish a clear communication system among team members, such as radios or hand signals, to coordinate movements and stay informed of potential hazards during installation. - Develop an emergency response plan specific to electrical incidents and machinery accidents, ensuring all workers are familiar with evacuation routes and first aid procedures. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
