ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Electrical shock, Tripping hazards	3H	<ul style="list-style-type: none"> - Ensure all electrical equipment, including burnishing machines, are tested and tagged according to AS/NZS 3760 standards. - Inspect the power cords and plugs for any visible damage before each use and replace if necessary. - Use Residual Current Devices (RCDs) for all connections to prevent electrical shocks. - Keep all walkways clear of cords by using cable management systems or concealing them under cord covers. - Mark out work areas with barriers or cones to warn others of ongoing activities and potential hazards. - Conduct a risk assessment of the area and identify and remove potential tripping hazards such as loose flooring or debris. - Ensure proper lighting is available to illuminate the entire working area and identify hazards more easily. - Use wet floor signs to alert others when conducting burnishing on polished or freshly cleaned surfaces. - Train workers to report any unsafe conditions immediately, including frayed cords or liquid spills. - Securely fasten cords running across open areas with tape or clips to prevent accidental unplugging or tripping. - Require employees to wear appropriate footwear with non-slip soles to reduce slipping risks. - Regularly maintain equipment to operate safely and identify any mechanical issues that may pose additional risks. - Have first aid kits readily accessible and ensure that a trained first aider is nearby in case of an emergency. 	2M

Burnishing Setup	Burns from hot surfaces, Heavy lifting injuries	3H	<ul style="list-style-type: none"> - Conduct a pre-start meeting to discuss the job's specific requirements and potential hazards with workers involved. - Ensure all workers are trained in safe manual handling techniques and understand the importance of maintaining correct posture and lifting practices. - Use mechanical aids such as trolleys or forklifts wherever possible to transport heavy equipment to minimise manual handling risks. - Provide workers with personal protective equipment (PPE) including heat-resistant gloves to mitigate the risk of burns from hot surfaces. - Allow equipment to cool down before initiating any maintenance or adjustments whenever feasible, to prevent contact with hot parts. - Implement a buddy system when lifting or moving heavy objects to distribute load evenly and reduce the likelihood of strain injuries. - Regularly inspect burnishing equipment for signs of wear or damage that could pose safety risks during operation. - Clearly mark the burnishing area with warning signs to alert nearby personnel of ongoing operations and potential hazards. - Establish and maintain clear communication protocols using hand signals or two-way radios if verbal communication is hindered by machinery noise. - Position tools and burnishing equipment in designated stable areas away from high-traffic zones to prevent accidental bumping and subsequent injury. - Schedule regular breaks to prevent fatigue, which can lead to careless mishandling of equipment and increased injury risk. - Maintain sufficient lighting in the work area to ensure all equipment and hazard signage are visible at all times. - Conduct routine drills on emergency procedures, ensuring all workers know how to respond in case of an accident or injury. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
