Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Lifting Trays	Musculoskeletal injury from improper lifting, Slips from trays oil	3H	<ul style="list-style-type: none"> - Ensure employees receive proper manual handling training focused on safe lifting techniques. - Encourage a two-person lift for trays that are excessively heavy or awkwardly shaped. - Use anti-slip mats in areas where trays are lifted to reduce the risk of slipping on spilled oil. - Regularly inspect and maintain flooring for slip hazards, cleaning any spills immediately. - Encourage the use of tray trolleys or carts to transport heavy trays whenever possible. - Provide slip-resistant footwear to employees to minimise the risk of slips. - Keep pathways free from obstructions to allow clear access when carrying heavy trays. - Implement a job rotation system to avoid prolonged periods of carrying heavy trays by the same person. - Encourage stretching exercises or warm-up activities before engaging in repetitive lifting tasks. - Apply proper gripping techniques and ensure secure handling of trays to prevent accidental drops. - Educate employees on recognising early signs of musculoskeletal strain and encourage reporting injuries early. - Limit the weight of trays to an acceptable standard as outlined by workplace health and safety guidelines. - Ensure trays are adequately balanced before lifting to prevent undue strain on specific muscle groups. - Use warning signage in spill-prone areas to alert staff of potential slip hazards and reinforce awareness. 	2M

- Use visual cues, like floor markings or signage, to guide staff along designated paths.
- Train staff on proper tray carrying techniques to maintain balance and prevent spills.
- Encourage communication between staff, such as calling out when approaching narrow doorways.
- Equip trays with non-slip surfaces or liners to prevent items from sliding off.
- Limit the number of trays carried at once to a manageable amount.
- Schedule regular breaks for staff to prevent fatigue and maintain alertness.
- Maintain adequate lighting conditions in all work areas to ensure visibility.
- Provide training on situational awareness to improve staff attention.
- Use mirrors at strategic locations, such as intersections and corners, to eliminate blind spots and increase visibility between colleagues and obstacles.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
