Safety meetings or toolbox talks will be sched and in accomposition with a gislative requirements to first identify any site hazards, hazards and then to further take steps to either eliminate or continuous each hazard.			
If an incident or a near miss occurs, all work must sto, adately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Use mechanical aids, such as trolleys or stair climbers, whenever possible to minimise manual handling. Ensure that the load is well-balanced and stable before attempting to move it up the stairs. Break down heavy or bulky loads into smaller, manageable sizes if feasible. Seek assistance from colleagues when lifting or carrying particularly heavy or awkward loads. Utilise team lifting techniques, ensuring clear communication and coordination amongst workers. Provide training on proper manual handling techniques and safe lifting practices to all involved personnel. Assess the worker's physical capabilities and ensure they are fit for the task prior to commencing work. Wear appropriate personal protective equipment, such as gloves, to improve grip and reduce the risk of injury. Clear the path of any obstructions or hazards that could increase the risk of tripping or falling while carrying the load. Ensure sufficient lighting in stairwell areas to enhance visibility during manual handling tasks. Plan the route in advance, identifying potential risks and implementing strategies to mitigate them. SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

- Spot Checks.
- 2. Consultation with workers, contractors and sub-contractors.
- 3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
