Provide appropriate personal protective equipment (PPE) such as chemical-resistant gloves, safety goggles, face shields, aprons, and long-sleeved clothing to protect against chemical burns and eye injuries. Ensure proper ventilation in the mixing area to prevent the accumulation of harmful fumes; utilise fume extraction systems if necessary. Designate a specific area for resin mixing away from general workspaces to contain any accidental spillages. Use containers designed for chemical mixing with tight-fitting lids to reduce the risk of spills and splashes during handling. SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.
