Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Exposure to hazardous material, Slip, Trips and Falls	3H	<ul style="list-style-type: none"> - Ensure all workers have completed asbestos awareness training and are familiar with the identification of hazardous materials. - Conduct an initial site inspection to identify any potentially hazardous materials present in the ceiling cavity, such as asbestos or fiberglass. - Use personal protective equipment (PPE) including gloves, masks, and coveralls specifically rated for protection against identified hazards. - Develop and communicate a clear work plan detailing the steps and safety measures to all workers involved in the ceiling cavity inspection. - Implement a Safe Work Method Statement (SWMS) that includes detailed risk assessment and control measures for potential hazards. - Ensure adequate lighting is available within the workspace to improve visibility and reduce the risk of slips, trips, and falls. - Clearly mark and secure the area below the inspection point to prevent unauthorised access during the inspection process. - Inspect and assess the stability of ladders and elevated platforms before use and ensure they are positioned on stable ground. - Use slip-resistant footwear to minimise the risk of slipping when accessing the ceiling cavity. - Establish a communication system between team members using handheld radios or mobile phones to maintain contact during the inspection. - Limit the number of individuals accessing the ceiling cavity at any one time to avoid overcrowding and maintain focus on safety protocols. - Provide harnesses and fall arrest systems if the work requires workers to be positioned near potential fall hazards. - Regularly inspect and maintain all tools and equipment used during the inspection to ensure they are in good condition and functioning properly. - Conduct a pre-task briefing re-emphasising the importance of following safety procedures and making sure everyone understands their roles and responsibilities. 	2M

Ceiling Cavity Entry	Fall from Heights, Unstable Surface	4A	<ul style="list-style-type: none"> - Ensure all workers involved in the inspection have completed height safety and ladder safety training. - Use a stable, certified ladder that is appropriate for the task and set it up on a firm, level surface according to manufacturer guidelines. - Secure the base and top of the ladder to prevent movement and use ladder locks or tie-offs when possible. - Conduct a pre-entry inspection to assess the structural integrity and stability of the ceiling cavity entry points and surrounding surfaces. - Use appropriate personal protective equipment (PPE), such as harnesses and fall arrest systems, if the risk of falling cannot be eliminated entirely. - Mark off or barricade the area below the inspection work site to prevent unauthorised access and minimise the risk of injury from falling objects. - Ensure there is adequate lighting in the ceiling cavity to identify any hazards such as weak points, electrical wiring, or other obstructions. - Work in teams or have another worker present for emergency response and communication purposes. - Limit the amount of tools and equipment taken into the ceiling cavity to avoid overloading and destabilising the surface. - Follow an emergency response plan specific to ceiling cavity inspections, including rescue procedures in the event of an incident. 	3H

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
