Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

2. Chainsaw Check	Faulty equipment, Lack of Personal Protective Equipment (PPE)	4A	<ul style="list-style-type: none"> - Prior to commencing the task, check all chainsaw equipment thoroughly. Ensure all parts are functional and in good working order. - Always do a test run of the chainsaw before beginning operations to identify any potential faults or defects that could pose a risk. - Conduct regular maintenance checks on the chainsaw system as per manufacturer's instructions. - Should any major issue with the chainsaw arise, report it immediately to the supervisor and do not proceed until it has been addressed. - Users must be trained in the correct usage of the PPE necessary for chainsaw operation. - Staff should wear appropriate PPE at all times during the operation of a chainsaw. This includes safety glasses, cut resistant gloves, sturdy footwear, helmet or hard hat, and hearing protection. - Chainsaw operator should be wearing high visibility clothing to ensure they are easily spotted by other workers, reducing risks of accidents. - Ensure extra PPE supplies are readily available onsite to replace any damaged equipment or cater for any additional workers. 	2M

Site Evaluation	Trip hazards, Overhead obstacles	1L	<ul style="list-style-type: none"> - Perform a comprehensive site assessment to identify any potential hazards such as trip hazards or overhead obstacles before starting work. - Make sure that the work area is clearly marked and signposted to prevent unauthorised people from accidentally entering the area. - Maintain a clean and tidy workspace to minimise tripping hazards. - Ensure all workers are wearing suitable personal protective equipment (PPE), including steel-capped boots to protect from tripping and falling debris. - Regularly inspect the work area for newly developed risks during the chainsaw operation, such as accumulated cuttings which may increase trip hazards. - Implement an effective communication system among workers to quickly flag new or emerging safety concerns. - All debris and offcuts should be removed regularly from the work zone to prevent trip hazards. - Use safety cones, signs and barriers where appropriate to mark overhead hazards if working under trees or structures. - Utilise proper training and correct manual handling techniques when carrying equipment to avoid trips and falls. - Work with a spotter or support person who can help to manage safety by observing for potential hazards. - Avoid working near overhead cables or power lines where possible, if it's necessary maintain safe clearance distance. - Limit work during poor weather conditions, such as high winds or rain, that could make conditions more dangerous. - Only use well-maintained, inspected equipment to ensure it is in safe operational condition, eliminating chances of sudden failures leading to disasters. 	1L



SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
