Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Improper training, Incorrect equipment use	3H	<ul style="list-style-type: none"> - Develop a comprehensive training program specifically for safe combination changing, ensuring it is aligned with industry standards. - Ensure all personnel involved in changing safe combinations have completed required training modules and are deemed competent. - Conduct refresher courses regularly to update workers on the latest practices and technologies related to safe operations. - Implement a buddy system where an experienced worker can guide and supervise less experienced members during the process. - Use clear and easy-to-follow operating instructions available at the site for quick reference. - Evaluate and certify all tools and equipment to be used during the procedure to ensure they meet safety standards. - Ensure that only authorised and trained personnel handle the tools and equipment required for the task. - Establish a checklist highlighting specific steps to follow to prevent incorrect use of machinery and equipment. - Provide personal protective equipment (PPE) appropriate to the nature of the task, like gloves and eye protection. - Maintain a log or record of all training, certifying that all personnel are equipped adequately before undertaking the task. - Carry out regular inspections of the environment where the task will be undertaken to identify and mitigate potential hazards. - Position warning signs and safety instructions prominently around the work area to alert workers to potential hazards. - Ensure that emergency contact information and first-aid kits are accessible in case of an incident. - Foster open communication channels where workers can report safety concerns without fear of reprimand or intimidation. 	2M

Check combination safe	Electrical hazards, Handling heavy objects	2M	<ul style="list-style-type: none"> - Ensure all employees involved are trained in managing and identifying electrical hazards associated with safes. - Conduct a pre-task risk assessment to identify potential electrical hazards and implement control measures accordingly. - Use insulated tools and wear appropriate personal protective equipment, such as rubber-soled shoes and insulating gloves, when handling any electrical components. - Ensure the safe is disconnected from the power source before starting any work to prevent accidental electrical shock. - Implement a lockout/tagout procedure to ensure the safe remains de-energised until the task is complete. - Use mechanical lifting aids or team lifting techniques to handle heavy parts of the safe, minimising manual handling risks. - Maintain good posture and utilise proper lifting techniques by bending at the knees and keeping loads close to the body to reduce the risk of strain. - Keep the workspace clear of trip hazards and clutter to allow for safe movement around the safe during combination checks. - Regularly inspect and maintain electrical components and wiring within the safe to ensure they are in good condition and comply with electrical safety standards. - Establish clear communication protocols among team members to coordinate actions and ensure everyone's safety during the task. - Ensure that emergency response procedures are in place and that first aid kits and trained personnel are readily available in case of any incident. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
