### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Identify Fault	Eye strain, Misdiagnosis	2M	<ul style="list-style-type: none"> <li>- Ensure adequate lighting in the workspace to minimise eye strain while inspecting and diagnosing locks.</li> <li>- Use magnifying glasses or optical tools to ease the process of viewing small lock components, reducing the risk of eye fatigue.</li> <li>- Take regular breaks from close-up work to rest eyes and prevent strain, following the 20-20-20 rule: every 20 minutes, look at something 20 feet away for at least 20 seconds.</li> <li>- Use ergonomic seating and workstation setup to maintain proper posture, preventing additional strain on eyes and body during diagnosis.</li> <li>- Provide training for employees on common lock mechanisms and problems to enhance diagnostic accuracy and reduce chances of misdiagnosis.</li> <li>- Utilise diagnostic tools like multimeters or automotive-specific scanners for precise fault identification, limiting reliance on guesswork and potential errors.</li> <li>- Implement a double-check system where another trained technician reviews the diagnosis to ensure accuracy before any corrective action.</li> <li>- Keep updated resources, such as repair manuals and technical bulletins, readily available to provide correct information for various lock types and issues.</li> <li>- Encourage clear communication with clients regarding symptoms and history of the lock's behaviour to gather valuable information that aids accurate diagnosis.</li> <li>- Utilise checklists and standard procedures to methodically assess lock functionality and potential faults, helping standardise the diagnostic process.</li> <li>- Promote a practice of continuous learning to stay informed about new automotive technologies and lock systems, ensuring skills remain current and effective for accurate diagnosis.</li> </ul>	1L

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
