Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Chemical exposure, slip and fall accidents	3H	<ul style="list-style-type: none"> - Proper Training: Ensure that all workers handling chemicals in the workplace have received necessary training and are familiar with the hazards associated with the chemicals as well as the appropriate safety procedures. - Personal Protective Equipment (PPE): Workers must wear appropriate PPE such as gloves, safety goggles, face shields, and chemical resistant clothing when working with chemicals to minimise exposure risks. - Material Safety Data Sheets (MSDS): Access to MSDS for all hazardous chemicals must be provided on-site, and employees should be familiar with their contents and follow the recommended safety precautions. - Chemical Storage: Store hazardous chemicals in designated areas with adequate ventilation, temperature control and away from incompatible substances to prevent accidental spills or reactions. - Labeling: Ensure all chemicals and containers used for baths and vats are clearly labelled with their contents and hazard warnings. - Proper Ventilation: Circulate fresh air throughout the workspace to help reduce the concentration of airborne contaminants. - Housekeeping: Regularly clean up chemical work areas to remove any spilled or leaked material and reduce the risk of slip and fall accidents. - Spill Containment Kits: Ensure that spill containment kits are readily available on-site in case of accidental spills, and workers are trained in their proper use. - Non-slip Flooring: Install non-slip flooring in chemical work areas to prevent slips and falls caused by wet surfaces or chemical spillage. - Emergency Procedures: Establish and enforce clear emergency response procedures, including evacuation plans, in case of chemical exposure or other workplace accidents. 			<ul style="list-style-type: none"> - Ensure fitted and individualized PPE is available for all employees working with chemical baths and vats, considering factors like size, gender, and potential allergies to materials that may come into contact with the skin. - Place visible signage near chemical vats or baths, indicating the required PPE for handling specific chemicals and ensuring workers are alerted before commencing work. - Develop and enforce disciplinary action, up to and including termination, for repeated or egregious violations of PPE requirements and associated work procedures. - Implement a buddy system, peer checks, where workers monitor one another for appropriate PPE use and fit, and report any issues to supervisors. - Consider implementing a PPE vending machine system, where workers can access required items using their unique identification and have record of when and which PPE items were obtained, ensuring traceability and accountability. - Regularly review and update PPE protocols in response to technological advancements or change in handling procedures or chemical composition. - Schedule regular toolbox talks promoting the importance of adequate and properly fitting PPE, sharing examples of incidents where incorrect PPE usage led to accidents and injuries. - Adopt a continuous improvement approach by gathering feedback from workers handling chemical baths and vats, identifying areas for potential improvement within the current PPE practices. - Ensure supervisors and managers are well-versed in PPE requirements and have a comprehensive understanding of the organisation's WHS policies, enabling them to lead by example and encourage a strong safety culture among workers.

Chemical Mixing	Exothermic reaction, hazardous fumes	4A	<ul style="list-style-type: none"> - Proper ventilation: Ensure that the mixing area is well ventilated to disperse hazardous fumes and minimise the risk of inhalation by workers. - Personal Protective Equipment (PPE): Provide appropriate PPE such as chemical-resistant gloves, safety goggles, and respiratory protection to prevent contact with harmful substances. - Training and supervision: All workers involved in the chemical mixing process should receive proper training and be supervised by qualified personnel to ensure safe handling practices. - Material Safety Data Sheets (MSDS): Ensure that MSDS for all chemicals being mixed are readily available and properly understood by workers to identify any potential hazards related to the chemicals. - Temperature monitoring and control: Implement continuous temperature monitoring and control systems to prevent exothermic reactions and overheating of the chemical mixture. - Emergency response plan: Develop a comprehensive emergency response plan in case of spills, fires, or other incidents involving the chemicals being mixed. Regularly conduct drills to familiarise workers with the appropriate response procedures. - Safe storage and handling of chemicals: Store chemicals in their designated areas and clearly label containers to avoid confusion during the mixing process. SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
