### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Here are some suggested control measures related to preparation and associated hazards in Chemicals Handling and Use :</p> <ul style="list-style-type: none"> <li>- All chemicals should be adequately labelled and stored per manufacturer's instructions and Material Safety Data Sheet (MSDS).</li> <li>- Regular risk assessments and hazard identification processes should take place.</li> <li>- Protective gear such as safety goggles, face shields, chemical-resistant gloves and aprons should always be worn when handling any type of chemical substance.</li> <li>- An effective ventilation system must be in place to ensure toxic fumes do not build up in the area where chemicals are being handled.</li> <li>- Ensure employees have received thorough Workplace Health and Safety (WHS) training in connection with storing, using, and disposing of chemicals.</li> <li>- Staff should receive regular training on first aid procedures for chemical exposure incidents.</li> <li>- Always perform a double-check mechanism for types, quantities and storage conditions before storage and use of chemicals.</li> <li>- Maintain an accurate registry of all chemicals present on-site and ensure it is easily accessible in cases of accidents or emergencies.</li> <li>- Implement a strict no food or drink policy in areas where chemicals are used and stored.</li> <li>- There should be clear communication about the potential hazards associated with each chemical, including physical and health risks.</li> <li>- Emergency exit routes and emergency assembly points should be clearly marked and free from obstructions at all times.</li> <li>- Regular drills and emergency response practices should be conducted to ensure everyone is aware of the processes to follow during an actual incident.</li> </ul> <p>These safety measures aim to prevent incorrect storage and exposure to chemical fumes. Remember that safety rules must be consistently applied to maintain a safe workplace.</p>	2M

			<ul style="list-style-type: none"> <li>- Clear labelling of chemicals: All containers of chemicals should be clearly labeled with information about their contents, hazards and the necessary precautions.</li> <li>- Safety data sheets: Have safety data sheets available for all chemicals being used, which provide details on their properties, hazards, safe handling protocols, and emergency procedures.</li> <li>- Controlled storage conditions: Store hazardous chemicals in designated areas, according to their compatibility groups to prevent reactions. The storage location should be well-ventilated, away from heat sources, and have spill control measures in place.</li> <li>- Regularly monitor environments: Conduct regular environmental monitoring to identify any changes that could increase the risk of exposure to employees.</li> <li>- Proper waste disposal: Implement proper waste disposal procedures for chemical waste to minimise the risk of contamination and exposure.</li> <li>- Emergency response measures: Develop and implement an emergency response plan specific to the chemicals in use, covering spills, explosions, fires etc.</li> <li>- Restrict access: Limit access to areas where chemicals are stored and used to properly trained staff only.</li> <li>- Regular breaks: Encourage workers who are handling chemicals to take regular breaks to decrease ongoing exposure risks.</li> <li>- Provision of information: Keep employees informed about the dangers of the materials they work with so they're aware of potential risks.</li> <li>- Noise control: If machinery working with chemicals make loud noise, ensure noise-control measures, like earmuffs, to prevent noise-induced hearing loss.</li> <li>- Ventilation: Good ventilation systems should be established where chemicals are stored and handled, this can help to minimise exposure to hazardous particles or gases.</li> </ul>

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
