Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Gather Cleaning Supplies	Chemical exposure, heavy lifting injuries	3H	<ul style="list-style-type: none"> - Use personal protective equipment (PPE) such as gloves and safety goggles to prevent skin and eye contact with cleaning chemicals. - Select cleaning agents that are less hazardous and eco-friendly to minimise chemical exposure risks. - Ensure all cleaning supplies are clearly labelled and stored properly to avoid accidental misuse or spillage. - Train employees on the safe handling, usage, and disposal of cleaning chemicals. - Provide Safety Data Sheets (SDS) for all cleaning products and ensure they are readily accessible at the worksite. - Implement proper manual handling techniques to reduce risk of injury from lifting heavy cleaning equipment or supplies. - Use mechanical aids like trolleys or carts when transporting heavy supplies to reduce physical strain. - Limit the weight of individual packages of cleaning supplies to a manageable level. - Conduct a pre-work inspection of the area to identify any potential hazards before starting the task. - Ensure adequate ventilation in the area to disperse any chemical vapors while cleaning. - Establish emergency procedures for spills or exposure incidents, including eyewash stations and first aid kits. 	2M

Set Up Ladder	Falling from height, unstable ladder setup	3H	<ul style="list-style-type: none"> - Conduct a pre-work inspection to ensure the ladders are in good condition, free from defects such as cracks, bends, or missing components. - Select the appropriate ladder type and height suitable for reaching the overhead fan without overreaching or standing on the top rungs. - Set up the ladder on a stable, level surface, ensuring that all feet are securely placed and not resting on loose material or uneven ground. - Use ladder stabilisers or anti-slip devices, if necessary to enhance ladder stability, especially on smooth or slippery surfaces. - Ensure the ladder is placed at the correct angle by maintaining the recommended 4:1 ratio (four units of vertical height for every one unit away from the wall or structure). - Secure the ladder at the top or bottom, if possible, particularly if there is a risk of it slipping or being accidentally knocked over. - Avoid setting up ladders near doorways, exits, or pedestrian traffic areas. If unavoidable, install barriers or signage to prevent accidental collisions. - Do not carry tools or equipment while climbing the ladder. Instead, use a tool belt or hoist equipment up separately once safely positioned. - Maintain three points of contact at all times when ascending or descending the ladder (e.g., two hands and one foot or two feet and one hand in contact with the ladder). - Ensure that only one person is on the ladder at any given time to prevent overloading and maintain balance. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
