### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Climbing onto Crane	Falls from height, collisions with objects	4A	<ul style="list-style-type: none"> <li>- Conduct a comprehensive risk assessment prior to beginning the task to identify and evaluate all potential hazards associated with climbing onto cranes.</li> <li>- Ensure all workers are trained in height safety procedures and have the necessary qualifications for working at height.</li> <li>- Use personal fall arrest systems including a full-body harness, shock-absorbing lanyard, and secure anchorage to prevent falls.</li> <li>- Verify that all climbing equipment, such as ladders or steps, meet Australian Standards and are regularly inspected and maintained.</li> <li>- Implement and maintain clear communication protocols between team members to ensure awareness of movements, especially when climbing or navigating around the crane.</li> <li>- Install temporary barriers or guardrails on platforms and access ways where possible to prevent falls from height.</li> <li>- Ensure environmental conditions, such as wind or rain, are monitored and work is postponed if conditions become unsafe.</li> <li>- Designate a spotter or supervisor to oversee the climbing activity, ensuring compliance with safety measures and readiness to act in emergencies.</li> <li>- Mark and illuminate pathways to and from the crane to enhance visibility and reduce the risk of collisions, particularly during low-light conditions.</li> <li>- Keep climbing paths free from obstacles and debris to prevent slips, trips, and collisions with objects.</li> <li>- Ensure that all personal protective equipment (PPE) like helmets, gloves, and safety boots are worn correctly at all times.</li> <li>- Establish exclusion zones at ground level to prevent unauthorised personnel from entering areas where they could be injured by falling objects.</li> <li>- Inspect the crane for stability and structural integrity before climbing to verify that it is safe to hold the climber's weight.</li> <li>- Conduct regular tool box talks and safety drills to reinforce safety procedures and keep safety front-of-mind.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
