### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Unauthorised access, improper training	3H	<ul style="list-style-type: none"> <li>- Setting up a well-structured induction program to ensure all workers are proficiently trained on the correct usage of compact loaders, including potential risks associated.</li> <li>- Conducting regular refresher training courses to maintain worker's skill levels, ensuring they are updated with the latest safety procedures and instructions.</li> <li>- Ensuring only certified and fully trained personnel have access to operate the compact loader, with strictly no unauthorised usage at any given time.</li> <li>- Implementing a sign-in/sign-out system for usage of the machinery to track who is operating it at any time.</li> <li>- Setting up clearly marked barriers or cordons around the work area to prevent unauthorised access and to keep non-essential personnel safe from hazards.</li> <li>- Keeping machinery keys secure when not in use to prevent unauthorised access to the machinery.</li> <li>- Regularly inspecting and maintaining all machinery and equipment to ensure they are in proper working condition before usage.</li> <li>- Encouraging safe manual handling techniques such as pushing instead of pulling, using mechanical aids wherever necessary, and bending knees when lifting heavy objects.</li> <li>- Providing and enforcing the use of appropriate Personal Protective Equipment (PPE) such as high visibility clothing, steel-toed boots, hard hats, gloves, and safety glasses.</li> <li>- Implementing emergency procedures and ensuring workers are thoroughly trained in these protocols, including evacuation procedures, emergency communication systems and first aid measures.</li> <li>- Clearly displaying safety signage and warnings around the site to remind workers of potential hazards and safety protocols.</li> <li>- Creating a planned preventative maintenance schedule for the compact loader to reduce risk of sudden malfunctions or failures.</li> <li>- Tracking near misses and incidents, then regularly reviewing and updating procedures based on these events, effectively promoting a continuous improvement in workplace safety.</li> </ul>	2M

			<ul style="list-style-type: none"> <li>- Ensure all operators have received sufficient training and are licensed to operate the compact loader under Australian regulations.</li> <li>- Maintain an ongoing preventative maintenance schedule to regularly service the loader and address potential issues before they become problematic.</li> <li>- Verify the presence and proper set up of safety guards, such as those around moving parts of machinery.</li> <li>- Use a checklist during pre-start inspections to demonstrate proper maintenance records, ensuring nothing has been overlooked.</li> <li>- Confirm that fire extinguisher and first aid kit are readily available and fully stocked.</li> <li>- If possible, consult with manufacturer guidelines or a trained professional if uncertain about any aspect of the loader's operation or safety capabilities.</li> <li>- Regularly update training protocols to reflect recent innovations in equipment safety features and operational procedures.</li> <li>- Before any major change in task or equipment use, carry out risk assessment involving all personnel, discussing safe work methods and effecting changes accordingly.</li> </ul>

Operating the Compact Loader	Incorrect operation, noise	4A	<ul style="list-style-type: none"> <li>- Conduct thorough training on the proper operation and maintenance of the compact loader, according to the manufacturer's guidelines.</li> <li>- Ensure all operators are certified and continuously updated with ongoing training, to prevent incorrect operation.</li> <li>- Provide operator with industry-approved ear protection equipment, to lower exposure to noise.</li> <li>- Regularly perform preventive maintenance checks on the compact loader, to guarantee functional and safe operations.</li> <li>- Make sure everyone in the immediate vicinity is aware of the machine at work, to reduce risks associated with inattentiveness or distractions.</li> <li>- Incorporate breaks in between long durations of work, to prevent fatigue that can result in mistakes when operating the loader.</li> <li>- Always inspect work site for hazards before initiating work, allowing any required risk mitigations to be performed first.</li> <li>- Use anti-vibration gloves as part of PPE whenever necessary, to limit exposure to vibrations that might cause injury over time.</li> <li>- Don't attempt repairs or adjustments unless fully trained and qualified, this helps avoid further damage or potential safety issues.</li> <li>- Determine a safe distance for non-essential personnel, maintaining this area clear during loader operations.</li> <li>- Communicate actively with team through radios or appropriate signalling methods, ensuring all members are alerted on loader movements.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
