Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Material Unloading	Manual handling injuries, Struck by moving object	3H	<ul style="list-style-type: none"> - Conduct a risk assessment before beginning the unloading process to identify potential hazards and determine appropriate controls. - Employ mechanical aids such as forklifts, cranes, or pallet jacks wherever possible to minimise manual handling. - Ensure all workers involved in material unloading have received proper training in manual handling techniques and safety procedures. - Use team lifting techniques for heavy or awkward items to distribute weight evenly among multiple workers. - Clearly mark and establish exclusion zones around unloading areas to prevent unauthorised personnel from entering and being struck by moving objects. - Equip workers with personal protective equipment (PPE), including high-visibility vests, hard hats, gloves, and steel-toed boots, to mitigate injury risks. - Implement clear communication protocols, such as hand signals or radios, between drivers, operators, and ground workers to coordinate unloading operations safely. 	2M

Foundations Installation	Tripping, falling from height	4A	<ul style="list-style-type: none"> - Conduct a site inspection to identify any uneven surfaces or obstacles that may pose a trip hazard and highlight these areas with high-visibility markers or cones. - Implement a clear housekeeping protocol to ensure pathways remain free of debris and tools, enhancing overall worksite safety. - Utilise temporary guardrails or edge protection systems on any raised work areas to mitigate the risk of falls from height. - Provide adequate training for all workers regarding safe practices when working at heights and reinforce the use of any fall prevention equipment. - Ensure that all ladders used are industrial-grade and comply with Australian Standards; regularly inspect them for damage or defects. - Require the use of personal protective equipment (PPE) such as hard hats, safety boots, and fall arrest systems where necessary. - Set up exclusion zones around the foundation work area to prevent unauthorised access by personnel not involved in the task. - Install temporary lighting if natural light is insufficient to ensure visibility during foundation installation work. - Reassess weather conditions regularly, and cease work during adverse conditions like heavy rain or strong winds that could increase risk levels. - Use scaffolding when necessary, ensuring it meets compliance standards and is erected by qualified personnel only. - Maintain communication protocols to ensure that team members are aware of everyone's location and activities, helping to prevent accidental trips or falls. - Engage in toolbox talks prior to commencement of work to discuss potential hazards and control measures specific to the day's tasks. - Develop an emergency response plan specifically tailored for incidents involving trips or falls, ensuring that all workers are briefed accordingly. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
