The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Read and follow all safety data sheets (SDS) for cleaning products to understand specific handling and exposure risks. Ensure ventilation in areas where chemical products are in use to reduce inhalation risk. Use appropriate manual handling techniques when lifting or transporting cleaning supplies, such as bending the knees and keeping a straight back. Limit the weight of cleaning supply containers to manageable levels to prevent strain or injury. Provide training on safe chemical handling and manual handling procedures to all staff involved in the clean-up process. Store cleaning chemicals in suitable, labelled containers to prevent accidental misuse or exposure. Use trolleys or carts to transport heavy or bulky cleaning supplies, reducing the need for manual carrying. 

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.
