The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.



Keep the work area tidy by organizing tools and materials to prevent slips and trips caused by scattered equipment or debris. Use non-slip mats or slip-resistant footwear to reduce the risk of slipping on wet or uneven surfaces in the work area. Implement manual handling techniques training for workers to reduce the risk of muscle strain when lifting heavy scaffold components. Utilise mechanical lifting aids such as hoists or forklifts to lift heavy materials whenever possible, instead of manual lifting. Conduct a site-specific risk assessment before beginning work to identify potential hazards and implement appropriate controls. Ensure proper communication among team members using hand signals or two-way radios to coordinate safe movement of materials and prevent accidents. 	2M

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:
