Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Material Selection	Sharp edges, Heavy lifting	3H	<ul style="list-style-type: none"> <li>- Conduct a risk assessment prior to commencing work to identify potential hazards associated with sharp edges and heavy lifting.</li> <li>- Provide appropriate personal protective equipment (PPE) such as cut-resistant gloves, safety goggles, and steel-capped boots for all workers handling scrap metals.</li> <li>- Use mechanical aids or lifting equipment like forklifts, trolleys, or cranes to move heavy materials instead of manual lifting to reduce the risk of injury.</li> <li>- Implement proper manual handling techniques, including bending at the knees and keeping loads close to the body for tasks that require human lifting.</li> <li>- Ensure clear communication and coordination among team members when lifting or moving bulky and awkwardly shaped materials.</li> <li>- Regularly inspect and maintain cutting tools to ensure they are in good condition and do not pose an additional hazard due to dull blades or faulty mechanisms.</li> <li>- Organise work areas to minimise clutter and provide adequate space to safely handle materials without unnecessary bending or twisting.</li> <li>- Conduct regular training sessions on safe handling practices and emergency response procedures for injuries involving sharp objects or lifting strains.</li> <li>- Establish a buddy system where employees can assist each other during tasks involving high-risk manual handling.</li> <li>- Clearly mark and properly store scrap metal piles to prevent trips and falls and make sharp edges easily noticeable.</li> <li>- Rotate tasks among workers to avoid prolonged exposure to repetitive movements and reduce the likelihood of strain injuries.</li> <li>- Ensure adequate lighting in work areas so that potential hazards are clearly visible to all workers.</li> <li>- Provide first aid kits readily accessible at the worksite and train staff in basic first aid procedures for cuts, punctures, and strain-related injuries.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
