ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Mitigating Noise Pollution	Long-term hearing issues, disturbance in communication	2M	<ul style="list-style-type: none"> - Conduct regular noise level assessments and monitoring to identify areas where noise pollution is a concern. - Provide appropriate personal protective equipment such as earmuffs or earplugs and ensure they are worn at all times in high noise areas. - Install sound barriers or dampeners around areas with high noise production to reduce the level of noise exposure. - Schedule work during hours that minimise disruption to nearby areas and align with local noise regulations. - Implement engineering controls such as maintaining equipment to ensure it operates as quietly as possible and replacing any noisy machinery with quieter alternatives if available. - Enforce mandatory hearing protection zones clearly marked with signage to alert workers when they are entering a high-noise area. - Rotate workers in and out of noisy environments to reduce their duration of exposure to high levels of noise. - Ensure comprehensive training and education for all personnel on the risks associated with noise pollution and the importance of using hearing protection. - Establish communication protocols that account for potential difficulties hearing over background noise, such as visual signals or radios with noise-cancelling features. - Conduct regular health surveillance checks focusing on hearing tests to identify early signs of hearing loss among employees. - Adopt administrative controls by setting time limits on workers' exposure to noisy environments during their shifts. - Engage with certified audiologists regularly to evaluate workplace noise protection measures and make necessary improvements. - Encourage and facilitate a safety culture where employees feel empowered to report concerns about noise levels and suggest improvements. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
