Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Inadequate workspace, Electrical hazards	3H	<ul style="list-style-type: none"> - Conduct a site assessment to ensure there is sufficient workspace and access for all workers involved in the formwork stripping process. - Clearly mark the work area with signage and barriers to prevent unauthorized entry and reduce congestion around the workspace. - Inspect the site for any electrical hazards, such as exposed wiring or nearby power lines, and ensure they are addressed or isolated before starting work. - Ensure that all electrical tools and equipment are in good working order and have current test and tag certifications. - Use non-conductive ladders and tools when working near potential electrical hazards to reduce the risk of electrical shock. - Arrange for a licensed electrician to identify and rectify any electrical issues observed during the site inspection. - Designate safe zones for formwork stacking to prevent clutter and maintain clear pathways for workers to move freely. - Provide adequate lighting at the worksite to improve visibility and reduce the risk of trips, slips, and falls. - Ensure that all workers involved in the task are trained in manual handling techniques to avoid musculoskeletal injuries. - Conduct toolbox talks emphasizing awareness and avoidance of electrical hazards and the importance of maintaining tidy work areas. - Regularly audit and review site conditions and control measures to ensure ongoing compliance and safety during formwork stripping. - Establish emergency procedures and ensure all workers know them, including how to respond to electrical accidents or workspace-related incidents. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
