The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Keep work areas clean and free from obstructions that may cause tripping or falling hazards. Avoid wearing loose clothing, jewellery, or anything that could get caught in moving parts. Clearly mark emergency stops and ensure they are easily accessible at all times. Use personal protective equipment such as safety glasses, gloves, and hearing protection as required. Ensure that all start-up procedures are followed as per the machine's operation manual. Regularly inspect power cords and other electrical components for signs of damage; immediately replace if necessary. Position cabling and wires safely away from travel paths to minimise trip hazards and potential for electrical incidents. 	2M

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors as support ractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel.
