Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

2. Check Equipment	Equipment malfunction, Electric shock	3H	<ul style="list-style-type: none"> - Conduct a pre-start inspection of the core rig equipment to identify any visible signs of wear or damage. - Verify that all electrical connections and wiring are intact, secure, and free from fraying or other damage. - Ensure the equipment has been tested and tagged by a certified electrician as required, and the testing is up-to-date. - Use Residual Current Devices (RCDs) for all portable electrical equipment to reduce the risk of electric shock. - Confirm that operators are trained and familiar with the manufacturer's instructions for safe use and troubleshooting of the core rig. - Maintain a schedule for regular preventative maintenance on the equipment to ensure it remains in good working condition. - Keep spare parts and essential tools readily available for minor repairs to prevent the use of faulty equipment. - Implement a lockout/tagout procedure during maintenance to prevent accidental energisation. - Ensure appropriate personal protective equipment (PPE), such as insulated gloves and safety footwear, is used when interacting with electrical components. 	1L

<p>Hit by moving vehicle</p>	<p>4A</p>	<ul style="list-style-type: none"> - Conduct a thorough site inspection to identify potential hazards and areas where equipment mounting will occur. - Erect temporary barriers or fencing around the work area to prevent unauthorized access by personnel or vehicles. - Ensure all workers on-site wear appropriate personal protective equipment, including high-visibility vests, and steel-toed boots. - Implement a spotting system to guide and direct vehicle movements to prevent collisions. - Use signage to clearly indicate work zones, vehicle paths, and potential hazards. - Schedule the delivery of equipment and materials during off-peak hours to minimize disruption during active operations. - Ensure that vehicles are fitted with reverse alarms and are regularly maintained. - Keep the work area clean and organise tools and materials to prevent clutter that could be dislodged. - Establish a protocol for safe lifting and securing of equipment on the mounting process. - Train workers on emergency response procedures in case of an accident involving moving vehicles. - Restrict the number of personnel in the immediate work area to minimize exposure to hazards. - Regularly review and update the Safe Work Method Statement to account for any changes in site conditions or processes.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
