ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Electric shock, Tripping over cords	3H	<ul style="list-style-type: none"> - Conduct a thorough hazard assessment before starting work to identify potential electrical risks and trip hazards. - Ensure that all power sources are turned off and properly tagged and locked out before handling any electrical wiring. - Use insulated tools and wear rubber-soled boots and gloves designed for electrical work to provide additional protection against electric shock. - Clearly mark work areas with signs and barriers to alert others of the presence of electrical work and reduce the risk of accidental contact. - Keep work areas tidy and free from unnecessary equipment or materials, especially near electrical cords to minimise the risk of trips and falls. - Securely tie down any cords or cables running across floors or walkways to prevent tripping hazards. - Regularly inspect all electrical equipment and cords for damage before use. Any faulty or damaged equipment should be removed from service immediately. - Ensure good lighting in all work areas to help workers clearly see and avoid potential trip hazards. - Provide training for all workers on safe work practices around electricity and the importance of maintaining tidy workspaces. - Maintain a first aid kit on site specifically equipped for dealing with electrical burns and injuries, and ensure workers are trained in emergency response procedures. 	2M
2. Shut off power	Accidental reconnection, Inadequate lighting resulting in trip hazards	3H	<ul style="list-style-type: none"> - Switch off the main power supply at the circuit breaker and lock it out using a lockout/tagout (LOTO) system to prevent accidental reconnection. - Clearly label the circuit breaker with tags indicating maintenance work is underway to alert others not to switch it on. - Use an approved and tested voltage detector to verify that power has been successfully shut off. - Deploy temporary lighting solutions such as battery-operated lamps or portable floodlights to ensure adequate visibility in the work area. - Inform all personnel working nearby about the power shutdown and instruct them to avoid operating any switches or electrical equipment. - Place cautionary signage around the work area to warn of ongoing electrical repairs and encourage vigilance. - Conduct a brief toolbox talk with the team before starting the work to reinforce safety protocols and hazard awareness. - Inspect the work area for potential trip hazards and remove obstacles, ensuring cables and tools are stored safely to maintain a clear walkway. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
