If an incident or a near miss occurs, all work must ste, anately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Conduct a pre-lift meeting to discuss the planned operations, potential hazards, and the hand signals that will be used. Designate one person as the signaler, and ensure they are easily identifiable with a high-visibility vest or other distinguishing garments. Position the signaler so they have a clear view of both the load and the crane operator at all times. Implement a communication system, such as radios, to supplement hand signals if direct line of sight is not possible. Use a backup signaler if the primary signaler's visibility is obstructed during the lift. Install adequate lighting for operations occurring in low-light conditions to ensure signals are clearly visible. Encourage regular breaks for signalers to prevent fatigue and maintain effective communication. SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.
