Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Crane Assembly	Instability, Operator error	3H	<ul style="list-style-type: none"> - Conduct a thorough site inspection to assess ground conditions and ensure stability before assembly. - Use ground mats or crane pads to distribute weight and prevent sinking or tilting on soft ground. - Implement a project-specific assembly plan that includes detailed steps and procedures tailored to the site conditions. - Train all personnel involved in crane assembly on proper procedures, including identifying and mitigating potential hazards. - Assign a competent person to supervise the crane assembly and monitor for signs of instability or procedural errors. - Ensure all equipment and tools used for assembly are inspected and deemed suitable for use prior to commencing work. - Verify that all manufacturer's guidelines and specifications for assembly are strictly followed. - Use a spirit level or other leveling device to confirm the base is perfectly level before proceeding with the crane assembly. 	2M

Load Assessment	Inadequate load hookup, Overloading crane capacity	3H	<ul style="list-style-type: none"> - Conduct thorough risk assessment before starting the task to identify potential hazards related to load handling. - Verify that the weight of the load does not exceed the crane's rated capacity by checking both the load documentation and the crane's specifications. - Ensure rigging gear is correctly rated for the load being lifted and has been inspected for damage or wear. - Use a certified signal person to direct crane operations, ensuring clear communication between the operator and ground crews. - Position the crane on a stable, level surface and use outrigger pads if necessary to increase stability. - Secure the load with adequate hooking techniques, using properly maintained and compatible slings, shackles, and hooks. - Apply tag lines to control the movement of the load during lift, preventing unintentional swinging or rotation. - Implement a lift plan that includes procedures for safe load handling, lifting paths, and emergency measures if unexpected issues arise. - Limit the working radius from the crane to the placement area to ensure control over the load throughout the operation. - Ensure the crane operator is certified and experienced in lifting operations specific to the load characteristics and conditions. - Inspect the area around the crane for obstacles or potential interference, including overhead power lines, and designate exclusion zones. - Schedule regular breaks for personnel involved in the operation to reduce fatigue-related mistakes, especially those responsible for load attachment. - Maintain open communication channels among the entire team, including spotters, to promptly address any concerns or changes during the lift. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
