Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Improper safety procedures, Unorganised working area	3H	<ul style="list-style-type: none"> - Conduct a thorough risk assessment prior to commencing any work to identify specific hazards related to the site and adjust control measures accordingly. - Ensure all personnel are adequately trained in safety procedures, including how to handle equipment safely and the proper use of personal protective equipment (PPE). - Establish a clear area around the fire site, free from flammable materials, and ensure that all equipment is organised and easily accessible. - Develop a comprehensive communication plan to coordinate between team members, including signals for emergency situations and progress updates. - Implement strict site access controls to prevent unauthorised personnel from entering the area during preparation and working activities. - Verify all fire-starting equipment is in good working condition and is appropriate for the controlled burn. - Assign a competent person to supervise and maintain safety standards throughout the preparation phase, ensuring compliance with all workplace health and safety regulations. - Maintain an inventory of fire extinguishing equipment on site, regularly inspect it, and ensure that it is fully operational. - Prepare a clear and concise emergency response plan, making sure all workers are familiar with it and know their roles in case of an incident. - Conduct a briefing session with all personnel involved to review the steps of the task, potential hazards, and control measures to mitigate risks. - Arrange equipment and materials in a neat, organised manner to reduce tripping hazards and allow for safe and efficient movement around the site. - Schedule weather monitoring to be sure conditions are favourable and will not increase the risk of the uncontrolled spread of fire. - Set up clear signage to alert others in the vicinity about the ongoing activity and associated hazards, maintaining awareness even after working hours. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
