Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Identify Location	Incorrect marking, Unwanted building damage	2M	<ul style="list-style-type: none"> - Ensure that site plans and blueprints are up-to-date and have been thoroughly reviewed before marking locations for penetrations. - Conduct a pre-work meeting with all relevant personnel to confirm the correct placement for outlets, switches, and vents. - Use precise measuring tools and laser levels to ensure accurate marking of penetration points. - Double-check all measurements and marking against architectural drawings and design specifications before proceeding. - Clearly communicate with other trades on-site to avoid marking penetrations in areas intended for other installations or services. - Mark penetration points using non-permanent materials that can easily be altered if changes are needed prior to cutting or drilling. - Implement a tagging system to identify each marked location, allowing easy cross-reference with plans and ensuring consistent communication. - Have a qualified supervisor review and approve all markings before any cutting or drilling begins. - Provide training for workers on reading and interpreting technical drawings to reduce mistakes during the identification stage. 	1L

<p>work area visibility</p>	<p>2M</p>	<ul style="list-style-type: none"> - Ensure all workers are wearing appropriate personal protective equipment, including safety glasses, and high-visibility clothing. - Erect barriers or fencing around the work area to prevent unauthorized access by bystanders. - Use signs to clearly indicate and warn about potential hazards, such as "Restricted Area". - Conduct a pre-work inspection to identify any loose materials or debris that have been knocked over or dislodged. - Implement effective housekeeping practices to keep the work area clear of materials that may contribute to clutter or visual obstruction. - Use strategic lighting placements to enhance visibility in areas with shadows or glare. - Assign a spotter to monitor the surroundings and keep an eye out for hazards that are not initially identified. - When feasible, schedule penetration activities during times of low traffic or reduced pedestrian entry into the hazardous area. - Regularly communicate with the entire team about the status of the work, current hazards and respective control measures. - Install netting or catch platforms underneath the work area to catch falling debris and injuries below. - Utilise equipment like vacuum or dust extraction systems to contain dust during the penetration process, contributing to better visibility and air quality. - Keep all cutting tools well-maintained and sharpened to ensure efficient work, minimizing unnecessary effort that might lead to mishaps.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
