Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Trip hazards, Exposure to harmful substances	2M	<ul style="list-style-type: none"> - Conduct a site inspection to identify potential trip hazards and clear the work area of unnecessary materials and debris. - Use signage and barriers to clearly mark off work zone, highlighting any existing trip hazards that cannot be removed immediately. - Ensure proper lighting in the work area to enhance visibility and reduce the risk of trips and falls. - Require all workers wear appropriate PPE such as safety boots with slip-resistant soles to reduce the chance of tripping or slipping. - Organise and store tools and equipment properly to maintain a clutter-free environment, minimising trip risks. - Establish designated walkways with anti-slip mats or coverings where needed to guide safe pass-through areas. - Train workers on good housekeeping practices, emphasising immediate cleanup of spills or obstructions on walking paths. - Implement regular inspections and maintenance schedules for equipment to ensure no cables or hoses are left lying across paths. - Utilise dust extraction and ventilation systems to minimise worker exposure to plasterboard dust and other harmful substances. - Choose low dust or pre-prepared plasterboard products to further reduce airborne particles during handling and cutting. - Provide training on safe material handling techniques and correct use of PPE such as respiratory protection to mitigate inhalation of dust and fibres. - Implement a strict policy on the storage and disposal of hazardous substances used in preparation activities to prevent accidental exposure. - Ensure all personnel are trained in emergency procedures, including first aid and response actions, specific to the potential hazards identified. - Regularly review and update safety data sheets (SDS) for all chemicals and educate workers on recognising substance-related symptoms. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
