Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Falling objects, Slips, trips, and falls	2M	<ul style="list-style-type: none"> - Conduct a pre-start meeting to discuss tasks and potential hazards with the work crew. - Ensure all workers are wearing appropriate personal protective equipment such as hard hats, steel-toed boots, high-visibility clothing, safety glasses, and gloves. - Set up exclusion zones around the work area to prevent unauthorised access and reduce the risk of injury from falling objects. - Inspect the work area for any debris or obstacles that could cause slips, trips, or falls and remove them before starting work. - Use signage and barricades to easily identify work zones and areas where there is a higher risk of falling objects. - Secure tools and materials on stable, level surfaces to minimise the risk of items being knocked over or accidentally dropped. - Provide adequate lighting in the work area to ensure visibility and further reduce the risk of trips and falls. - Ensure all workers are familiar with emergency evacuation procedures and have a means of communication in case of an accident. - Regularly check the condition of walkways and paths of travel within the work area to keep them clear of hazards. - Train workers on proper manual handling techniques to safely lift and move bricks and other heavy materials. - Ensure that ladders and scaffolding are set up correctly and are in good condition if used during the preparation phase. - Monitor weather conditions and postpone outdoor work if conditions such as rain increase the likelihood of slips and falls. 	1L

Equipment Check	Angle grinder malfunction, Improper use of personal protective equipment (PPE)	2M	<ul style="list-style-type: none"> - Conduct a pre-start inspection of the angle grinder to ensure it is in good working condition. - Verify that the angle grinder is equipped with the correct disc for brick cutting and that the disc is free from any damage or excessive wear. - Ensure the power cord of the angle grinder is free from cuts, fraying, and other damages that could pose electrical hazards. - Only allow trained and competent personnel to operate the angle grinder. - Confirm that all safety guards are properly fitted and functional to prevent debris from causing injury. - Make sure that all workers are wearing appropriate PPE such as safety glasses, hearing protection, and dust masks or respirators as required. - Check that gloves used are suitable for grip and protection without compromising dexterity. 	1L

Positioning Angle Grinder	Hand-arm vibration syndrome, Burns from hot workpieces	3H	<ul style="list-style-type: none"> - Ensure all operators are trained and competent in the use of angle grinders, including understanding the risks associated with hand-arm vibration syndrome. - Use anti-vibration gloves to help reduce exposure when operating the angle grinder. - Limit the duration of continuous use and incorporate regular breaks to minimise hand-arm vibration exposure. - Select low-vibration model of angle grinder to reduce vibration exposure. - Conduct pre-use inspection of the angle grinder to ensure it is in good working condition. - Position workpieces securely using clamps or vices to minimise movement during cutting. - Maintain a safe distance from colleagues and bystanders to prevent accidents or unexpected interference. - Wear appropriate personal protective equipment (PPE), such as long sleeves and non-flammable clothing, to protect against burns. - Allow the grinder and workpiece to cool down before handling to prevent burns from hot surfaces. - Utilise guards and protective barriers on the angle grinder to contain sparks and heat. - Ensure that the work area is free from flammable materials to avoid fire hazards due to sparks. - Regularly monitor and maintain equipment to prevent overheating and potential burn threats. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
