Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Checking Material Quality	Splinters, sharp edges	2M	<ul style="list-style-type: none"> - Wear appropriate personal protective equipment, including gloves and long sleeves, to prevent splinters and cuts from sharp edges. - Inspect all materials for defects such as knots, splits, or irregularities before cutting, and only use high-quality materials. - Use a push stick or similar tool to handle smaller or awkward pieces of material to maintain distance from sharp edges. - Keep the work area well-lit to clearly see any potential hazards on the materials being handled. - Utilise material supports or stands to hold materials securely while checking, preventing movement that could lead to injury. - Apply sandpaper or a file to any rough or sharp edges to minimise the risk of splinters and lacerations. - Maintain a clean and organised workspace, free from debris or unnecessary clutter, to reduce tripping hazards while handling materials. - Ensure all staff receive adequate training about recognising and managing splinters and sharp edges before handling materials. - Store materials properly, stacked safely and away from pathways to avoid accidental contact with sharp edges. - Use mechanical aids where possible to move larger and heavier materials, reducing manual handling risks. - Keep first aid kits accessible in case of injuries from splinters or sharp edges, including antiseptic wipes and bandages. - Regularly check and maintain saw blades to ensure they are not contributing to sharp edges or splinters on cut materials. - Rotate tasks among workers when possible to prevent fatigue, which can increase the likelihood of accidents and injuries. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
