Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Measure and Mark	Exposure to dust, Incorrect measurements causing rework/accidents	2M	<ul style="list-style-type: none"> - Use personal protective equipment (PPE) such as dust masks and safety goggles to reduce exposure to dust particles. - Implement a dust extraction system or wet cutting method to minimise airborne dust during the measuring and marking process. - Regularly maintain and inspect all tools and equipment to ensure they are in safe working order, reducing the risk of accidents caused by faulty instruments. - Use accurate and calibrated measuring devices to ensure precise measurements and reduce the likelihood of rework or miscuts. - Clearly mark all measured lines with non-permanent markers to avoid confusion and ensure visibility without causing permanent damage to materials. - Train workers on proper measuring and marking techniques to improve accuracy and reduce the likelihood of errors that may lead to accidents or rework. - Provide adequate ventilation in the work area to disperse dust particles and improve air quality for workers. - Establish and enforce standard operating procedures to guide workers in correct measurement and marking practices. - Encourage a double-check system where another team member verifies measurements before proceeding with cutting to catch any potential errors early. 	1L

Setting up Mitre Saw	Moving heavy equipment, Electrical hazards	3H	<ul style="list-style-type: none"> - Ensure team members are trained in manual handling techniques to prevent injury while moving the mitre saw. - Use appropriate lifting equipment such as trolley or dollies when transporting the mitre saw. - Inspect the mitre saw for any visible damage before use, and report and repair any defects immediately. - Ensure that the electrical cords are in good condition without any frays or cuts. - Connect the mitre saw to a power source equipped with a residual current device (RCD) to minimise electrical hazards. - Provide adequate personal protective equipment such as gloves and safety boots to protect against injuries from moving heavy equipment. - Establish a clear, clutter-free workspace around the mitre saw station to prevent trips and falls. - Implement a buddy system where two workers move the equipment together to reduce the risk of strains or sprains. - Ensure plugging in of electrical equipment only through sockets meeting the Australian standards to avoid electric shocks. - Make sure that the saw is on a stable, sturdy surface capable of supporting its weight securely. - Use lockout/tagout procedures during set-up to ensure the equipment cannot be accidentally activated. - Verify that all safety guards on the mitre saw are in place and operational before proceeding with setup. - Ensure proper ventilation in the work area to reduce the risk of inhaling dust and other particles produced during operation. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
