Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Improper storage, Unfamiliarity with procedures	2M	- Ensure all personnel involved in the decommissioning process receive comprehensive training on safe handling and storage procedures, along with the specific steps for decommissioning gas bottles to mitigate risks associated with unfamiliarity with procedures. - Develop a detailed Standard Operating Procedure (SOP) for decommissioning gas bottles and make it accessible to all workers. Regularly review and update this SOP to reflect any changes in regulations or best practices. - Conduct a pre-storage briefing focusing on the risks of improper storage and the importance of adhering to established decommissioning procedures. - Clearly label designated storage areas for gas bottles awaiting decommissioning to prevent any inappropriate or accidental use. - Implement strict access controls to areas where gas bottle decommissioning is in progress, restricting entry to authorised and trained personnel only. - Store gas bottles upright and secure them to prevent tipping, using stands or restraining devices designed for gas bottle storage. - Perform regular inspections of gas bottles and storage facilities to ensure they are maintained in good condition and free from potential hazards like corrosion or damage. - Keep the decommissioning area well-ventilated to minimise the risk of gas accumulation should a leak occur during preparation for decommissioning. - Ensure that all gas bottles are correctly identified and rated for the type and pressure of gas they contain. Decommissioned gas bottles should be labelled as such and processed according to standard decommissioning procedures. - Provide appropriate personal protective equipment (PPE) to all workers involved in the decommissioning process, including gloves, safety goggles, and other gear relevant to the specific types of gas being handled. - Establish clear communication protocols to be used during the decommissioning process, facilitating immediate reporting and response to any safety incidents or concerns related to improper storage or procedure adherence. - Set up an emergency plan that includes immediate evacuation procedures, first aid measures, and incident reporting in case of any hazardous occurrences during the preparation stage of gas bottle decommissioning. Ensure this emergency plan is well-communicated and understood by all staff.	1L

			- Confirm that the work area is well-ventilated, either naturally or through mechanical means, to prevent the accumulation of potentially flammable gases. - Implement a 'no ignition sources' policy within the vicinity, which includes prohibiting smoking, avoiding the use of mobile phones, and eliminating any nearby activities that could generate sparks or flames. - Instruct workers to utilise the correct manual handling techniques and mechanical aids when moving and inspecting gas bottles to avoid musculoskeletal injuries. - Provide comprehensive training for staff on how to identify defective or damaged gas bottles, understanding that such cylinders must be removed from service and properly labelled according to Australian standards. - Develop and enforce a strict protocol for testing and monitoring of the atmosphere for flammable and toxic gases before and during the decommissioning process. - Regularly maintain and inspect all safety equipment, including gas detection monitors and PPE, to ensure this is in good working order and complies with Australian safety standards. - Establish clear communication procedures amongst team members for reporting hazards, sharing information about gas bottle conditions, and responding to emergencies. - Ensure that all personnel involved in the inspection of gas bottles have received formal training in Hazardous Substances and Dangerous Goods Handling, as well as in the specific procedures detailed in the Safe Work Method Statement (SWMS).	
3. Isolating the gas supply	Flammable environment, Inadequate ventilation	4A	- Ensure that all workers involved in the decommissioning process are equipped with flame-retardant clothing and personal protective equipment (PPE), including eye protection and gloves suitable for handling flammable materials. - Conduct a thorough risk assessment specific to the location to identify any additional hazards before beginning the work, and share this assessment with all staff involved in the operation. - Implement strictly enforced no-smoking and no-open-flame policies in and around the work area to prevent ignition of flammable gases. - Utilise gas detection equipment to monitor for any presence of flammable gases continually. The detection equipment should be regularly calibrated and maintained according to the manufacturer's guidelines. - Maintain proper ventilation in the work area at all times to prevent the accumulation of flammable gases. Use mechanical ventilation if natural ventilation is insufficient to ensure safe levels of oxygen and prevent build-up of hazardous atmospheres. - Train all workers on the correct procedures for isolating the gas supply, including the use of any relevant tools and emergency shutdown protocols. This training should be documented and regularly refreshed. - Develop and clearly communicate an emergency response plan in case of gas release or other incidents, which includes immediate evacuation routes and muster points. - Ensure that the gas isolation procedure is double-checked by a qualified individual. This could involve confirming that valves are fully closed and locked out or tagged out to prevent accidental re-pressurisation of the system.	3H

		- Prior to isolation, purge the gas system following appropriate procedure at a minimum, using inert gas like nitrogen if necessary to displace associated piping. - Have fire-fighting equipment readily available and accessible, including flammable gas fires, and ensure all personnel are trained in their use.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
