ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Final Inspection	Eye Strains, Overexertion	2M	<ul style="list-style-type: none"> - Ensure adequate lighting in the area to reduce eye strain and improve visibility during inspection. - Use task-specific goggles or safety glasses, if necessary, to protect eyes from irritants or particles. - Take regular breaks to rest eyes, especially after long periods of close inspection. - Position yourself at a comfortable distance and angle when inspecting carpet conditions to avoid eye stress. - Adjust workstations or areas where inspection takes place to support ergonomic practices. - Use magnifying tools if needed to ensure detailed inspection without straining eyes. - Employ proper posture techniques while inspecting by standing upright and avoiding awkward positions. - Utilise mechanical aids or tools for lifting or movement to prevent overexertion. - Conduct stretching exercises before beginning the inspection to prepare muscles and reduce the risk of injury. - Implement a buddy system to share the workload and minimise physical fatigue. - Train staff in correct manual handling techniques and posture. - Schedule inspections in shorter durations, with planned rest intervals to maintain alertness and physical well-being. - Rotate tasks among employees to distribute workload evenly and decrease strain on individuals. - Ensure that any equipment used for inspection is adequately maintained and suited to minimise physical effort. 	1L

Equipment Dismantling	Lifting Heavy Objects, Electric Shock	3H	<ul style="list-style-type: none"> - Conduct a manual handling risk assessment before starting the dismantling process to identify any potential hazards. - Use mechanical aids such as trolleys or lifting straps when moving heavy equipment to reduce strain. - Ensure all electrical equipment is disconnected from power sources before dismantling to prevent electric shock. - Train staff in safe lifting techniques and proper posture to minimise the risk of injury. - Implement a buddy system where two people work together to lift and move heavier components safely. - Inspect all tools and equipment for any visible damage or faults prior to use during the dismantling process. - Provide personal protective equipment (PPE) like gloves with good grip to protect hands while lifting and handling equipment. - Clearly label and follow lock-out/tag-out procedures to ensure machines are fully de-energised before any work begins. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
