Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

2. Inspect Deep Freezer	Electrocution, Injury from moving parts	ЗН	 Provide training for all workers on identifying electrical safety risks within the freezer environment. Ensure power to the deep freezer is turned off at the main switch before inspection begins. Use lockout/tagout procedures to prevent accidental reactivation of the freezer during inspection. Verify with a qualified electrician that all electrical systems are safe and disconnected before proceeding. Wear appropriate personal protective equipment (PPE) such as insulated gloves and footwear. Check for any exposed wiring or damaged cables and report them for immediate repair. Keep tools and equipment away from water or ice to prevent electrocution risk. Ensure all team members understand emergency procedures in case of electrical shock. Conduct a pre-inspection safety briefing highlighting potential hazards, focusing on moving parts. Identify and avoid areas where fans and other moving components may start unexpectedly. 

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.
