Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Trip hazards, electrical shocks	3H	<ul style="list-style-type: none"> - Conduct a risk assessment prior to commencing work to identify potential trip hazards and sources of electrical risks. - Ensure all personnel involved are adequately trained in hazard identification and safe work practices relevant to utility disconnection. - Use appropriate warning signs and barriers around the work area to alert others to potential trip and electrical hazards. - Ensure work areas are well lit to improve visibility and minimise the risk of tripping. - Utilise cord covers or cable management systems to keep cables and hoses organised and out of walkways. - Inspect all tools and equipment before use to ensure they are in good working condition and free from damage. - Ensure all power tools and equipment are tested and tagged in accordance with relevant standards to prevent electrical faults. - Establish a clear communication protocol among workers, including the use of hand signals or radios if required. - Wear appropriate personal protective equipment (PPE) such as safety boots and non-conductive gloves to protect against trip and electrical hazards. - Ensure access to first aid equipment and trained personnel is readily available nearby the workspace. - Implement lockout/tag-out procedures to ensure that utilities cannot be accidentally reconnected during the disconnection process. - Consult and verify with utility provider for complete understanding and documentation of service locations and disconnection points. - Schedule tasks to avoid peak times when there may be higher traffic in the work area, reducing the risk of trips. 	2M

Isolate and Lock Out	Ineffective lock out, incomplete isolation	3H	<ul style="list-style-type: none"> - Conduct a thorough assessment of the equipment and systems that require isolation to ensure all energy sources are identified. - Use an isolation or lockout tag to provide clear identification of who has locked out the equipment and when. - Ensure isolation procedure includes clear diagrams and instructions to facilitate effective lockout by any authorised personnel. - Verify isolation points using photos or schematics to confirm all connection points are addressed. - Implement a training program for employees to ensure familiarity with lockout and isolation procedures, including recognising different energy forms and their hazards. - Use suitable locking devices that fit correctly on switches, valves, or other control points to maintain the integrity of the lockout. - Develop a checklist to verify completion of each step in the isolation process, reducing the risk of incomplete isolations. - Require a second person to independently check the effectiveness of the lockout to provide a fresh perspective on the completeness of the isolation. - Use an audible alarm system to alert workers of ongoing lockout procedures, keeping unauthorised personnel away from controlled areas. - Keep a detailed logbook of all lockouts with date, time, person responsible, and equipment affected to track ongoing safety operations. - Colour code lockout devices to indicate levels of danger or types of energy, assisting quick recognition for authorised workers. - Implement a permit-to-work system requiring sign-off by a supervisor before commencing work on isolated utilities, ensuring managerial oversight. - Regularly audit and review lockout/tagout procedures and update them based on feedback or incidents to continually improve safety measures. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
