Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Ensure the work area is well-lit to improve visculiforand reduce the risk of tripping over unseen obstacles. Use appropriate signage to adicate ongoing disconting actifores to alert others to potential risks. Keep walkways and access places clear of furniture and and tools to prevent tripping incidents. Train staff on placer man all harming techniques, emphasizing safe lifting practices like bending at the knees, not the daist. Provide emptodes with carsonal produce equipment (PPE) such as gloves to enhance grip and prote to ainst sorrouges. Utilis muchanical add like trolleys or dollies to transport heavy or awkward furniture components safely. Encounge our lifting for bulky items to distribute weight evenly and reduce the likelihood of strain or injury. As ange turniture pieces systematically, grouping similar components together to make reassembly efficient or organised. Table desassembled parts and hardware to minimise confusion and errors in reassembling, reducing time spent in awkward or unsafe postures. Ensure all personnel understand emergency procedures and are trained in first aid should an incident occur. 	1L
2. Assessment of Furniture	Cuts, Splinters	2M	 Conduct a thorough inspection of the furniture to identify any sharp edges or rough surfaces before starting work. Ensure all workers wear appropriate personal protective equipment, including cut-resistant gloves and long-sleeved shirts, to prevent cuts and splinters. Use tools that are specifically designed for dismantling furniture to minimise the risk of injury. Train workers on safe handling techniques for tools and materials to reduce the risk of cuts. Clearly mark and remove any damaged or hazardous parts of the furniture before commencing work. Keep the workspace clean and free of debris to avoid accidental contact with sharp or splintered pieces. Utilise appropriate lifting techniques and aids to prevent strain or injury when assessing large or heavy furniture parts. 

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel.
