Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Slips, trips and falls, Incorrect lifting technique	2M	<ul style="list-style-type: none"> - Ensure adequate housekeeping practices are maintained throughout the work area, by regularly cleaning and clearing any waste materials or obstructions that pose a risk for slips, trips, and falls. - Keep all walkways, working spaces, and access ways free from obstacles, cords, and cables to prevent tripping hazards. - Provide appropriate signage to indicate potential slip, trip, or fall hazards within the work area and ensure all workers are aware of these areas. - Ensure that employees wear closed toe, slip-resistant footwear with proper support and grip to minimise the risk of slips, trips, or falls. - Train employees in proper lifting techniques to avoid injury while handling heavy equipment or materials. This includes bending at the knees, keeping the back straight, and lifting with the legs instead of the back. - Encourage regular breaks and stretching exercises for workers engaged in repetitive tasks or heavy lifting throughout the day to reduce the risk of injury due to fatigue or overexertion. - Use appropriate lifting aids or equipment, such as trolleys, hand trucks, and hoists, when moving heavy items to prevent injuries related to incorrect lifting techniques. - Ensure the Drill Pedestal is secured properly and is located on a flat, stable surface to prevent accidental tipping, wobbling or falling over during use. - Conduct a thorough risk assessment prior to commencing work to identify potential hazards associated with the task, and implement applicable control measures to manage these risks effectively. - Provide ongoing supervision and training to employees on maintaining situational awareness and practicing safe work procedures in the workplace, reinforcing the importance of vigilance in preventing slips, trips, and falls, as well as adhering to correct lifting techniques. 	1L

Inspection	Electric shock, Insecure work area	3H	<ul style="list-style-type: none"> - Ensure proper inspection of electrical cords, plugs, and equipment for any visible signs of wear, damage, or fraying prior to use. SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
