Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Vehicle Familiarisation	Unawareness of vehicle controls, Unfamiliarity with vehicle	2M	<ul style="list-style-type: none"> - Conduct a comprehensive vehicle orientation session before the first use to educate drivers on all vehicle controls and features. - Provide opportunity for drivers to ask questions and practice using critical controls such as headlights, windshield wipers, and emergency signals. - Supply a detailed vehicle manual in the glove compartment for quick reference, ensuring it is easily accessible at all times. - Encourage drivers to spend time inside the parked vehicle to familiarise themselves with the dashboard layout and control positions before starting their journey. - Arrange for test drives under supervision to help drivers gain confidence in handling the vehicle and using its various controls comfortably. - Use visual aids, such as labelled diagrams or infographics, highlighting key controls and functions within the cabin to assist novice drivers. - Implement a peer-review system where experienced colleagues share tips and offer guidance on operating different vehicle types. - Enforce the use of standardised vehicles across the fleet where possible to reduce the need for excessive familiarisation processes. 	1L

Trucks, Driving under	3H	<ul style="list-style-type: none"> - Plan the route in advance including rest stops every two hours to avoid fatigue. - Use GPS or mapping tools to identify safe areas for breaks and refueling. - Ensure there is a designated rest period of at least 20 minutes per driver. - Schedule inspections to allow sufficient travel time, avoiding the need for rushed checks. - Rotate drivers when possible to share the driving responsibilities. - Arrange accommodations for overnight stays if the trip exceeds a day. - Use fatigue-monitoring technology or apps that alert when signs of fatigue appear. - Avoid driving during peak fatigue times, such as between midnight and 5 AM. - Implement a travel logbook to track driving hours and rest periods. - Educate workers on recognising signs of fatigue and the importance of taking breaks. - Provide access to communication devices to maintain contact with dispatchers or support teams.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
